

Preparing the 7-Day Trial – text

Slide 1

Read this first.

Slide 2

Welcome to the 7-Day Trial of “Life to the Full”.

In this trial, you will be given FULL access to the entire programme, including lesson plans, video content, prayers, music, teacher training materials and the online parent platform.

This is a brand new programme which is packed full of media-rich content. We are still developing some of the resources but you will see that the vast majority of the programme is in place and ready to use.

In order to protect the content, we have put some restrictions in place on the resources that you will access.

Slide 3

Before starting the trial to Ten Ten Resources, you need to ensure that you have the correct licensing software installed on your computer.

Each user needs to have the following:

- A username and password to access the site;
- A license from an organisation called ‘LockLizard’ installed on the device (computer, tablet, etc) that you are using to view the files.

We’ll explain more about this on the following pages.

Slide 4

On the 7-Day Trial, each school is allowed a maximum of three users. Each registered user will be given their own unique username and password.

Once your trial begins, you will have access the following materials with your unique username and password:

- All resource pages
- All video content

- All presentation content
- The option to download PDF resources (license required to view - see next page)

Before the trial begins, please ensure that every user has been given their unique username and password.

Slide 5

Almost all of the printed content in the programme is in the form of 'protected PDF' documents.

This means that every trial user need to download a piece of licensing software on their device in order to access the document.

We will send all of the licences in one batch to the Programme Coordinator who will then have the responsibility to ensure that ever device being used to download materials has the licence installed.

Slide 6

You will receive an email from LockLizard Licensing called Viewing LockLizard Protected Files. The text in the email states that it is from 'The Ten Ten Charitable Trust'. It looks like this:

Welcome to The Ten Ten Charitable Trust protected files service

The Ten Ten Charitable Trust has authorized you to use their protected PDF files.

Select your operating system below and follow the instructions on that page to install the Viewer, activate your license, and view protected files.

To view documents from The Ten Ten Charitable Trust you must activate your license:

Follow the instructions on the email to download the licence on your computer. This is a simple process on a personal computer. However, if a computer is on a school network, the process may be slightly more complicated as you may not have Admin Rights. In this instance, please discuss installing the licence with your IT Technician. We have provided more detailed information for IT Technicians below.

Slide 7

Once you have the LockLizard Licence installed, you will be able to open and view all of the protected PDF documents. However, for the 7-Day Trial, printing will be disabled (printing will be enabled if you take out a full subscription).

After 7 days, your access to these files will be disabled and you will no longer be able to access the “Life to the Full” site.

Slide 8

Once you have installed the licence on each computer, please test that you can access the resources using the test resources below:

- The Protected PDF document
- The sample video

Once testing has been complete and you are ready to proceed with the 7-Day Trial, please contact the Ten Ten office to let us know and we will start your trial on the agreed date.
